Finally, I hereby acknowledge that I am fully conversant with the risk and dangers of motor sports in general which I assume hereby.

(a) Arising out of any failure to observe the International Sporting Code of the FIA or any regulations laid down by FMSCI or any conditions or amendments thereto or the provision of the Supplementary Regulations for this event for which the Applicant have entered.
